**Invitation to the rebidding on the offer request

Public Joint Stock Company Center for Cargo Container Traffic TransContainer (PJSC TransContainer) (hereinafter referred to as the Customer), guided by the regulations of the Federal Law No. 223-FZ of July 18, 2011 "On Procurement of Goods, Work, Services by Certain Types of Legal Entities" and the Regulation on Procedure for Procurement of Goods, Work, Services for needs of PJSC TransContainer (hereinafter referred to as the Procurement Regulation), in accordance with the Minutes of the meeting of the Bidding Commission of PJSC TransContainer's central office No. 12.2 /KK dated 26.02.2018 carries out a rebidding via reduction of the price of initially submitted applications by the participants, as well as an extend of the period of free storage of goods in a warehouse/container yard of the Supplier provided that the rest of the provisions of application are kept intact.

The decision of the Bidding Commission of PJSC TransContainer's central office adopted in accordance with paragraph 2.9.9 of documentation on procurement and Chapter 9 of the Procurement Regulation. The participants that submitted bids on the specified offer request and were allowed to participate in the offer request may submit their new proposals.

The new proposal should be prepared in accordance with Annex No. 1 to this invitation and signed by a representative having the authority to sign the offer.

Information on the form and procedure for rebidding

The rebidding is conducted in absentia. Along with the change of the price in direction of decreasing, the participants may extend the free period of storage of goods in the Supplier's warehouse/container yard. Offers for deterioration of initial terms are not considered, such participant is considered not participating in the rebidding, while his offer remains valid with the earlier offered terms.

Information on the procedure for submission of offers

Financial and commercial offers, defining the changed terms of the application are provided in the manner prescribed for filing.

The participant is entitled to withdraw the submitted offer with new terms at any time prior to the deadline for the submission of bids to the rebidding.
