Joint-Stock Company 'Centre for the Transport of Goods in Containers TransContainer' (JSC TransContainer), hereinafter referred to as the 'Lessor', represented by Petr Vasilievich Baskakov, Director General, acting under the Articles of Association, on the one part, and Open Joint-Stock Company Russian Railways (RZD), hereinafter referred to as the 'Lessee', represented by Elena Akimovna Kunaeva, Director General of the Center for Corporate Transport Services, a department of RZD, acting under power of attorney No. 698-D of the sixth of July two thousand nine, on the other part, hereinafter collectively referred to as the 'Parties', enter into this Supplementary Agreement (hereinafter, the 'Supplementary Agreement') to Agreement on Lease of Medium-Tonnage Containers of JSC TransContainer of October 15, 2007 No. 106-zhd (hereinafter, the 'Agreement') and agree as follows:

1. Paragraph 9.2 of the Agreement shall be amended as follows:

'9.2 This Agreement becomes effective as of March 1 (first), 2007 and remains in effect to December 31 (thirty first), 2010, and to the extent of settlements and the return of the leased containers, until the Parties perform their obligations under this Agreement in full.'

2. Section 10 of the Agreement shall be amended as follows:
