No. 212 - the Federal Law "About Insurance Payments to the Pension Fund of the Russian Federation, Social Insurance Fund of the Russian Federation, Federal Compulsory Health Insurance Fund and Territorial Funds of Obligatory Medical Insurance", regarding tariffs of insurance payments), and also change of the list of the services rendered to JSC RZhD and their cost under the contract on the order of interaction of JSC RZhD and JSC TransContainer at the container terminals belonging to JSC RZhD from January 15, 2007 No. 3.

carriages and containers will be used under the lease contract of carriages and containers of open joint stock company TransContainer from September 9, 2006 No. 69/TsFTOAPS-36/1.

The parties to the transaction: JPJSC TransContainer (Lessor) and JSC RZhD (Lessee).

The subject of the transaction: the prolongation of validity period, and change of bank details of the Parties, location addresses, the postal addresses, numbers of contact phones, fax, and also change of types of the carriages and/or containers leased, and types of transportations for which carriages and containers will be used.

13.67. To approve the conclusion of supplementary agreements on prolongation of validity period, and also change of bank details of the Parties, addresses of the location, postal address, numbers of contact phones, fax, the indexation of remuneration of PJSC TransContainer for making available of 40 and 60 foot fitting platforms for use of JSC RZhD, and also modifications and additions (including cancellation) under the contract from June 03, 2014 No. 425.

The parties to the transaction: JPJSC TransContainer and JSC RZhD.

The subject of the transaction: prolongation of validity period, and also change of bank details of the Parties, addresses of the location, postal address, numbers of contact phones, fax, the indexation of remuneration of PJSC TransContainer for making available of 40 and 60 foot fitting platforms for use of JSC RZhD, and also modifications and additions (including cancellation).
